## PROJECT FACT SHEET

### PROJECT LOCATION

The Dane County Highway Department, in conjunction with the Wisconsin Department of Transportation, is proposing a bridge and approach replacement on CTH A in Dane County. This project will replace the existing three span steel girder concrete deck bridge with a two span 36-inch prestressed concrete girder bridge. The project is 500 feet in length, ±175 feet east and west of the bridge. A project location map is attached for your reference.

### PROJECT NEED

The existing bridge is in very poor condition.

### PROPOSED IMPROVEMENTS

- Replace the existing structure with a 36-inch prestressed concrete girder bridge with railings.
- Replace the existing approaches with new asphalt roadway with 11-foot lanes, 5-foot paved shoulders, and 1-foot gravel shoulders.

### OTHER INFORMATION

New right-of-way is not anticipated though temporary easements may be needed for this project.

### PROJECT SCHEDULE

- Final Plan Submittal – November 2016
- Construction begins - Summer 2017
- Work to be completed in approximately 3 to 4 months.
